Pursuant to Article 31(2) of the Law on Protection of Competition ("Official Gazette of the RS", no. 51/09), the Council of the Commission for Protection of Competition, on the session held on March 7, 2011, enacts a following

# TARIFF ON THE LEVEL OF COMPENSATION FOR ACTIVITIES WITHIN THE COMPETENCE OF THE COMMISSION FOR PROTECTION OF COMPETITION

## Article 1.

This Tariff shall determine the level of compensation for decisions and acts that are issued by the Commission for Protection of Competition (hereinafter: the Commission) at the request of undertakings.

## Article 2.

The level of compensation at the request of undertakings is for:

- 1. issuing the decision on the application for an individual exemption of restrictive agreements under which the exemption is not granted (Article 60 of the Law) set in the amount of the RSD equivalent of EUR1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 2. issuing the decision on the application for an individual exemption of restrictive agreements under which the exemption is granted (Article 60 of the Law) set in the amount of the RSD equivalent of EUR1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 3. issuing the act on the rejection of notification of concentration (Article 65(4) of the Law) set in the amount of the RSD equivalent of EUR500.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 4. issuing the act on the termination of procedure on notification of concentration (Article 38 of the Law) set in the amount of the RSD equivalent of EUR900.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 5. issuing the decision on the prohibition of concentration (Article 65(3) of the Law) set in the amount of the RSD equivalent of EUR1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 6. issuing the decision on the permissibility of concentration in summary procedure (Article 65(1,3) of the Law) set in the amount of 0.03% of joint total annual income of all concentration participants generated in the preceding financial year, and no more than the amount of the RSD equivalent of EUR25,000.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 7. issuing the decision on the permissibility of concentration in investigation procedure and conditional approval of concentration (Article 65(3) and Article 66 of the Law) set in the amount of 0.07% of joint total annual income of all concentration

participants generated in the preceding financial year, and no more than the amount of the RSD equivalent of EUR50,000.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;

- 8. issuing the act on the extension of deadline for further sale of stocks or shares at the request of the acquirer of the stocks or shares (Article 18(2) of the Law) set in the amount of the RSD equivalent of EUR700.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 9. issuing the act related to Article 132(10) of the Law on Bankruptcy stipulating the sale of all or part of the property of the bankruptcy debtor's estate in accordance with the Law set in the amount of the RSD equivalent of EUR1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;
- 10. issuing the act related to Article 157(3) of the Law on Bankruptcy stipulating the measures for implementation of reorganization plan in accordance with the Law set in the amount of the RSD equivalent of EUR1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment;

## Article 3.

Funds payed as appropriate compensation listed in Article 2 of this Tariff shall be deposited to the account of the Commission for Protection of Competition, as per reference number of the listed request/notification at the moment of submission of the corresponding request/notification.

## Article 4.

As from the date this Tariff comes into force, the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition ("Official Gazette of the RS", no. 58/06) shall cease to apply.

# Article 5.

This Tariff, upon the Government approval, shall enter into force on the eighth day from the date of publication in the "Official Gazette of the Republic of Serbia".
