On November 25, 2011, President of the Commission for Protection of Competition, pursuant to Article 37, paragraph 2 of the Law on Protection of Competition ("Official Journal of the RS", no. 51/09) and Article 2, paragraph 1, item 6, of Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition ("Official Journal of the RS", no. 47/2011) deciding under notification of concentration no. 6/0-02-844/2011-1 submitted, against power of attorney, by lawyer Mr. Bojan Vuckovic, from Beograd, law office Karanovic & Nikolic, Resavska 23, Beograd, on behalf of company Evonik Degussa Peroxid GmbH, incorporated in line with the laws of Austria, entered with the Klagenfurt Court under reference no. FN 95515p, with head-office at Fabrikstrasse 1, 9721 Weissenstein, Austria, and company Treibacher Industrie AG, entered into Klagenfurt Court under reference no. FN 198543a, with head-office at Auer von Welsbach Strasse 1, 9330 Treibach, municipality of Althofen, issued a following

Decision

I Concentration of market participants is approved in summary procedure created as a result of establishment of joint venture company consisting of two legal entities, company Aktivsauerstoff GmbH, with registered head-office at Auer von Welsbach Strasse 1, 9330 Treibach, municipality of Althofen, Austria, entered with the Klagenfurt Court under reference number FN 128765k, and company Evonik Persalze GmbH, with registered head-office at Rellinghauser Strasse 1-11, 45128 Essen, Germany, with registered business address at Rodenbacher Chaussee 4, 63457 Hanau, Germany registered with court registry in Essen under reference number HRB 22216, whereas joint venture company shall be under joint control of company Evonik Degussa Peroxid GmbH, incorporated in line with the laws of Austria, entered with the Klagenfurt Court under reference number FN 95515p, with head-office at Fabrikstrasse 1, 9721 Weissenstein, Austria, and company Treibacher Industrie AG, entered with the Klagenfurt Court under reference

number FN 198543a, with registered head-office at Auer von Welsbach Strasse 1, 9330 Treibach, municipality of Althofen, Austria.

II It is established that company Evonik, as one of joint applicants of concentration, effected payment, in prescribed period, of EUR 12.500,00 to the foreign currency account of Commission for Protection of Competition maintained with National Bank of Serbia, and that company Treibacher, as a joint applicant of concentration, effected, to the same account, the amount of Eur 12.466,00, and to the dinar account of the Commission maintained with the Treasury within the Ministry of Finance, the amount of EUR 34 in dinar countervalue of 3.515,86 dinars, thus the payment of the total amount of compensation prescribed for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition, was made.
