On September 7, 2012, member of the Concil of the Commission for Protection of Competition, under the authorization of the President of the Commission for Protection of Competition no. 1/0-06-625/2012-1, dated August 30, 2012, and pursuant to Article 37, paragraph 2 of the Law on Protection of Competition ("Official Journal of the RS", no. 51/09) and Article 2, paragraph 1, item 6, of Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition ("Official Journal of the RS", no. 49/2011) and Article 13, paragraph 2 of the Statute of the Commission for Protection of Competition ("Official Journal of the RS" no. 49/2010), deciding under notification of concentration entered under ref. no. 6/0-02-603/2012-1, submitted, on behalf of client - company Robert Bosch GmbH, with head-office at Robert Bosch - Platz 1, 70839 Gerlingen – Schillerhohe, Republic of Germany, under power of attorney, by Ms. Srdjana Petronijevic, lawyer from Beograd, Francuska 27, issued a following

DECISION

I Concentration of market participants is approved in summary procedure created by acquisition of indirect control on the part of company Robert Bosch GmbH with registered head-office at Robert Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Germany, organized in compliance with the laws of the Republic of Germany and entered into Trade Register B of the Commercial Court in Stuttgart under reference number HRB 14000, over particular property of company Izo Brasil Consultoria Ltd., with head-office at Alameda Santos, 1827, Conj 71, 72 and 181, Cerqueira Cesar Sao Paulo, Brasil, as a result of taking-over certain number of agreements with clients of company Izo, real property making infrastructure of the communication center of company Izo, defined number of employed in company Izo and agreement on lease of office premises of company Izo, by one of subsidiaries of company Robert Bosch GmbH – company Robert Bosch Centro de Comunicacao Limitada, with head-office at Avenida Andrade Neves, 2412, room 101, Centro Empresarial Castelo, Campinas, Sao Paulo, Brasil.

II It is established that the applicant in relevant concentration effected payment of RSD 2.951.107,50, in prescribed period, to the account of Commission for Protection of Competition no. 840-0000000668-16, maintained with Treasury within the Ministry of Finance of the Republic of Serbia, reference no. 6/0-02-603/2012-1, representing corresponding dinar countervalue of prescribed level of compensation for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition.
