On August 24, 2012, President of the Commission for Protection of Competition, pursuant to Article 37, paragraph 2 of the Law on Protection of Competition ("Official Journal of the RS", no. 51/09) and Article 2, paragraph 1, item 6, of Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition ("Official Journal of the RS", no. 47/2011), deciding under notification of concentration no. 6/0-02-548/2012-1, submitted under power of attorney by lawyer Ms. Milica Bulatovic from law office Wolf Theiss, PC Usce, Bulevar Mihajla Pupina 6, 11070 Novi Beograd on behalf of client – German company with limited liability Finedining Capital GmbH, with registered head-office at Leopoldstrasse 8 -10, c/o Hengeer Mueller, 80336 Munich, Republic of Germany, issued a following

## DECISION

I Concentration of market participants is approved in summary procedure created by acquisition of individual control on the part of company Finedining Capital GmbH, with registered head-office at Leopoldstrasse 8 -10, c/o Hengeler Mueller, 80336 Munich, Republic of Germany, referene number HRB 199653, over shareholding company WMF Wurttembergische Metallwarenfabrik Aktiengesellschaft, incorporated and registered in the Republic of Germany, under reference no. HRB 540215, with a location for performing its operations at Eberhardstrasse 17 - 47, in 73312 Geislingen an der Steige, as well as over company with limited liability WMF Versicherungsdienst – Gesellschaft mit beschränkter Haftung providing insurance services, incorporated and registered in the Republic of Germany under reference no. HRB 540166, performing its operations at Eberhardstrasse in 73312 Geislingen an der Steige, as a result of contracted take-over by company Crystal Capital GmbH, as present owner of two target companies, of at least 52% of shares of company WMF Wurttembergische Metallwarenfabrik Aktiengesellschaft, as well as 100% of share capital in company WMF Versicherungsdienst - Gesellschaft mit beschränkter Haftung.

II It is established that the applicant in relevant concentration effected payment, in prescribed period, of 25.000,00 EUR to the foreign currency account of the Commission for Protection of Competition maintained with National Bank of Serbia, reference number 6/0-02-548/2012-1, representing corresponding level of compensation for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition.
