DECISION

I Concentration of market participants is approved in summary procedure created by acquisition of exclusive and sole control on the part of limited liability company Elianta Trading Ltd., with registered head-office at Arch. Makariou III, 155, Proteas House, 5 floor, P.C. 3026, Limassol, Cyprus, registration no. HE 227386, over the following group of Ukraine's companies: Merus d.o.o., registration no. 37701636; Abrio d.o.o., registration no. 37700920; Akys d.o.o., registration no. 37700936; Kliios d.o.o., registration no. 37700852; Modus Kapital d.o.o., registration no. 37700907; Ridos d.o.o., registration no. 37700847, Santos Kapital d.o.o., registration no. 37700941; Validus d.o.o., registration no. 37193307, all located at the same registered address Muzeyny Provulok, house 10, 01001 Kiev, Ukraine and all in the ownership and under control of the same company; as well as acquisition of sole control on the part of company with limited liability Yernamio Consulting Ltd., with registered head-office at Arch Makariou III, 155, Proteas House, 5 floor, P.C. 3026, Limassol, Cyprus, registration no. Verkhovnoii Rady, House 7, 02100 Kiev, Ukraine, registration no. 21574573, in the ownership of the same group of companies to which the current owner of all Ukrainian companies to be taken over by company Elianta Trading Ltd., belongs.

II It is established that the applicant of relevant concentration, effected payment, in prescribed period, of 25.000,00 EUR to the foreign currency account of the Commission for Protection of Competition maintained with National Bank of Serbia, reference no. 6/0-02-618/2012-1, representing corresponding level of compensation for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6, of the Tariff on the level of compensation for activities within the competency of the Commission for Protection of Competition.
