Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-838/2016-1 submitted on December 6, 2016 by private company „Al Robin Limited“, with registered seat at the address 110 Fetter Lane, London, United Kingdom of Great Britain and Northern Ireland EC4A IAY, via plenipotentiary Bojana Miljanović, attorney from the Law office “Karanović and Nikolić” o.a.d., with registered seat at the address 23 Resavska Street, Belgrade, on December 30, 2016, the President of the Commission for Protection of Competition enacts the following

## **DECISION<sup>1</sup>**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of „Al Robin Limited“, with registered seat at the address 110 Fetter Lane, London, United Kingdom of Great Britain and Northern Ireland EC4A IAY, registered in the Registrar of companies of England and Wales under company registration number 10473726, that is wholly owned subsidiary of the funds managed by „Advent International Corporation“, with registered seat at the address 75 State Street, Boston, MA 02109, United States of America, over public company „Brammer“ Plc, with registered seat at the address St Ann’s House, 1 Old Market Place, Knutsford, Cheshire, WA16 6PD, United Kingdom of Great Britain and Northern Ireland, registered in the Registrar of companies of England and Wales under company registration number 162925, established by acquisition of Brammer’s equity shares by which Advent funds shall acquire individual indirect control over the said company.

**II IT IS ESTABLISHED** that the applicant of notification on concertation has executed the

payment in the amount of EUR 25,000.00 (in words: twenty-five thousand Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
