Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-30/2017-1 reference number: 6/0-02-899/2016-1, submitted on December 28, 2016 by Dole Asia Holding Pte. Ltd. company, with registered seat at the address 10 Marina Blvd #34-03, Marina Bay Financial Centre, Singapore 018983, represented by Senior Vice-President and Company’s Secretary Timothy J. Oswald, and Mr. Radoje Cvetić, personal identification number 0804957710117, with residence in Belgrade, 8 Kapetana Miloša Žunjića Street, submitted via joint plenipotentiary, the Law office “Karanović and Niković” o.a.d., with registered seat at the address 23 Resavska Street, Belgrade, on January 26, 2017, the President of the Commission for Protection of Competition enacts the following

DECISION¹

I Concentration of undertakings in summary procedure **IS APPROVED** created by change in control form from sole to a joint control, where Dole Asia Holding Pte. Ltd. company, with registered seat at the address 10 Marina Blvd #34-03, Marina Bay Financial Centre, Singapore 018983, registered in the competent registerer of Sigapore under company registration number 201224535W, shall acquire a joint control with Mr. Radoje Cvetić, personal identification number 0804957710117 with residence in Belgrade, 8 Kapetana Miloša Žunjića Street, as an exclusive and finite member of the Target company prior to transaction, over Company for processing, freezing, cold storage and trade of agricultural products Master Fruits Ltd. Belgrade – Palilula, company registration number 2120226, with registered seat at the address 6

II IT IS ESTABLISHED that applicants of notification have executed the payment in the amount of RSD 2,000,000.00 and amount of RSD 1,090,492.50 to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, that is RSD 3,090,492.50 (in words: three million, ninety thousand, four hundred ninety-two and five tenths Dinars), which in total represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
