Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-865/2016-1, submitted by Petrol LLC Beograd, with registered seat at the address 12v Partrijarha Dimitrija Street, Rakovica, Belgrade, represented by plenipotentiary attorney Igor Isailović, with registered seat at the address 5 Dobrinjska Street, Belgrade, on January 31, 2017, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of sole and independent control on the part of Petrol LLC Beograd, with registered seat at the address 12v Partrijarha Dimitrija Street, Rakovica, Belgrade, with company registration number 17454404, over the part of other undertaking, LLC Promist Novi Sad, with registered seat at the address 11 Hajduk Veljkova Street, Novi Sad, with company registration number 08770549, that can represent a sole and independent business entirety, as follows: petrol station in Leštane, municipality of Grocka, at the land register plot no. 42/2 KO Leštane, registered in the Real estate folio in the land register no. 2224 KO Leštane, and marked in the A list in the following manner: Number 1 BARE – land with a constructed building – structure 7a 15m²; Number 2 BARE - land with a constructed building 78m²; Number 3 BARE - land with a constructed building 13m², and BARE - land next to a building – structure 52a 88m², totaling to 60a 94m²; all marked in the B list in the following manner: petrol station building under ordinal number 1; petrol station building - gasoline pump facility under ordinal number 2, and power substation under ordinal number 3.

II IT IS ESTABLISHED that Petrol LLC Beograd, with registered seat at the address 12v

Partrijarha Dimitrija Street, Rakovica, Belgrade, has fully performed against its commitment relating to paying determined amount of the fee as compensation for issuing this decision on January 6, 2017, by executing the payment in the amount of RSD 3,090,492.50 (in words: three million, ninety thousand, four hundred ninety-two and five tenths Dinars), which represents the RSD equivalent of EUR 25,000.00 (in words: twenty-five thousand Euro) calculated at the National Bank of Serbia's middle exchange rate on the day of payment, to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance.
