Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-576/2016-1, submitted on August 5, 2016 by ArcelorMittal CLN Distribuzione Italia LLC, with registered seat at the address Corso Susa 13/15, 10040 Caselette, Italy, via plenipotentiary Srđan Janković and other attorneys from the Law office „Petrikić & Parneri“ AOD from Belgrade, 3 Cincar Jankova Street, on September 12, 2016, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of joint venture company ArcelorMittal CLN Distribuzione Italia LLC, with registered seat at the address Corso Susa 13/15, 10040 Caselette, Italy, founded in accordance with the Italian legislation and registered in the Business Registers of Torino under company registration number 11233970018, and indirect joint control of its founders - companies ArcelorMittal Distribution Solutions Italia LLC, with registered seat at the address Viale Brenta 27/29, 20139 Milano, Italy, registered in the Chamber of Commerce and Industry of Milano under company registration number MI-1795155, and C.L.N. – Coils Lamiere Nastri JSC, with registered seat at the address Corso Susa 13/15, 10040 Caselette, Italy, registered in the Business Registers of Torino under company registration number 00521230011, over company Acierplus LLC, to be founded with registered seat at the address Impasse Des Prairies, Zone Industrielle Nord, 69400, Arnas, France, created by acquiring 100% of shares in Acierplus LLC.

II IT IS ESTABLISHED that „Petrikić & Parneri“ AOD from Belgrade as the plenipotentiary party of the applicant of Notification, has on August 8, 2016 executed payment in the amount of RSD 3,081,975.00 (in words: three million, eighty-one thousand, nine hundred seventy-five Dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, which represents determined amount of the fee as compensation for issuing the decision on approval of concentration in summary procedure.
