Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-173/2017-1, submitted on January 27, 2017 by company British American Tobacco Investments (Central & Eastern Europe) Limited, with registered seat at the address Globe House, 1 Water Street, London, WC2R 3LA, registered in the Registrar of Companies for England and Wales under company registration number 2898824, via plenipotentiary, attorney Tijana Kojović from the Law office “BDK Advokati” a.o.d., with registered seat at the address 23 Majke Jevrosime Street, Belgrade, on February 21, 2017, President of the Commission for Protection of Competition enacts the following

## **DECISION<sup>1</sup>**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company British American Tobacco Investments (Central & Eastern Europe) Limited, with registered seat at the address Globe House, 1 Water Street, London, WC2R 3LA, registered in the Registrar of Companies for England and Wales under company registration number 2898824, over tobacco related intellectual property rights and intellectual property agreements of company Fabrika duhana Sarajevo, with registered seat at the address 5 Pofalićka Street, Sarajevo 71000, Bosnia and Herzegovina, company registration number 65-02-0013-10, and its subsidiary Tobacco Press LLC Mostar, with registered seat at the address 62 Blajburških žrtava Street, Mostar, Bosnia and Herzegovina, company registration number 58-01-0031-10, by acquiring 100% of shares in the said company.

**II IT IS ESTABLISHED** that the applicant of notification has executed the payment in the amount of RSD 3,100,367.50 (in words: three million, one hundred thousand, three hundred
