Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-208/2017-1, submitted by Robert Bosch LLC, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Germany, represented by plenipotentiary attorney Srđana Petronijević from Belgrade, 15 Dobračina Street, on March 9, 2017, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-165/2017-3 of March 2, 2017, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company Robert Bosch LLC, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, FR Germany, registered in the Commercial Register B of the Basic Court in Stuttgart under company registration number HRB 14000, via its subsidiary company – direct acquirer ETAS Embedded Systems Canada Inc., with registered seat at the address 595 Burrard Street, Suite 2600 Vancouver, Canada, with company registration number 81830061, over company TrustPoint Innovations Technologies Ltd., with registered seat at the address 450 Phillip Street, Suite 101, Waterloo, Canada, with company registration number 002342474, by acquiring 100% of shares.

II IT IS ESTABLISHED that company Robert Bosch LLC, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, FR Germany, has fully performed against its obligation related to paying the determined amount of the fee as compensation for

issuing this decision on approval of concentration in summary procedure on March 8, 2017, by executing payment in the amount of RSD 3,095,005.00 (in words: three million, ninety-five thousand and five Dinars) which represents an equivalent value of EUR 25,000.00 (in words: twenty-five thousand Euro) calculated at the National Bank of Serbia's middle exchange rate on the day of payment, to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance.
