Pursuant to Article 22(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192 of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/2010), and Article 2(1/2) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/2011), deciding under the request for individual exemption of restrictive agreement from prohibition submitted by Uniqa Nonlife Insurance Company Belgrade, with registered seat at the address 134g Milutina Milankovića Street, and Wiener Stadtische Joint Stock Insurance Company Belgrade, with registered seat at the address 1 Trešnjinog cveta Street, via plenipotentiary attorney Srđana Petronijević from the Law office Morvačević, Vojnović i partneri from Belgrade, 15 Dobračina Street, during the 60th Session of III Convocation held on March 7, 2016, Council of the Commission for Protection of Competition enacts the following

DECISION¹

I Restrictive agreement - Group Bidding Agreement no. 104/16 (registry number at Uniqa Nonlife Insurance Company) and 97/2016 (registry number at Wiener Stadtische Joint Stock Insurance Company) **IS EXEMPT FROM PROHIBITION** concluded on February 4, 2016, between Uniqa Nonlife Insurance Company Belgrade, with registered seat at the address 134g Milutina Milankovića Street, and Wiener Stadtische Joint Stock Insurance Company Belgrade, with registered seat at the address 1 Trešnjinog cveta Street, on the objective of joint participation of group of bidders in the public procurement procedure no. 13/15, for the City of Belgrade Administration – Secretariat for Education and Children’s Welfare as the Contracting Authority, 1/XVIII Kraljice Marije Street, Belgrade.

II PERIOD IS DETERMINED regulating individual exemption from prohibition of restrictive agreement from Paragraph I of enacting terms of this Decision in the duration of 1

(one) year initiating from the day of commencement of coverage, in the case of concluding insurance policy contract as per implemented Public procurement.

III Commitment **IS ESTABLISHED** and **IS ORDERED** to the request applicants that as the compensation fee for issuing this Decision execute the payment set in the amount of RSD equivalent of EUR 1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment, to the account of the Commission for Protection of Competition number 40-0000000880668-16 maintained with the Treasury Administration, reference number 4/0-03-185/2016, no later than seven days from the day of receiving this Decision.
