Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-410/2016-1, submitted by companies CEFC Hainan International Holding Co. Ltd., with registered seat at the address Tower 7, Yangpu Bonded Port Stage One Area, Hainan, PR of China, and KazMunayGas JSC, with registered seat at the address 19 Kabanbai Batyr Ave., Astana, Republic of Kazakhstan, represented by plenipotentiary Dragan Gajin and other attorneys from the Law office “Karanović and Nikolić” from Belgrade, 23 Resavska Street, on June 15, 2016, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of companies CEFC Hainan International Holding Co. Ltd., with registered seat at the address Tower 7, Yangpu Bonded Port Stage One Area, Hainan, PR of China, single company registration number 9146030056795637XJ, and KazMunayGas JSC, with registered seat at the address 19 Kabanbai Batyr Ave., Astana, Republic of Kazakhstan, company registration number 11425-1901-AO and business identification number 020240000555, over company KMG International Plc. Ltd., with registered seat at the address Strawinskyalaan 807, Tower A-8, 1077 XX, Amsterdam, the Netherlands, company registration number 24297754, created by acquiring 51% of capital stock on the part of CEFC Hainan International Holding Co. Ltd. from KazMunayGas JSC, as a sole previous shareholder.

II IT IS ESTABLISHED that company KMG International Plc. Ltd, with registered seat at the address Strawinskyalaan 807, Tower A-8, 1077 XX, Amsterdam, the Netherlands, has fully performed against its obligation related to paying determined amount of the fee as compensation for issuing this decision on May 26, 2016, by executing payment in the total amount of EUR 25,000 (in words: twenty-five thousand Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia.
