Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the Notification on concentration entered under number 6/0-02-595/2016-1, submitted on August 16, 2016 by „MPP Jedinstvo“ JSC Sevojno, with registered seat at the address bb Prvomajska Street, Užice, Republic of Serbia, via plenipotentiary attorney Aleksandra Stojić from the Law office „Dražić, Beatović & Stojić“, with registered seat at the address 29 Kralja Milana Street, Belgrade, Republic of Serbia, on August 26, 2016, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of „MPP Jedinstvo“ JSC Sevojno, with registered seat at the address bb Prvomajska Street, Užice, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07188307, over “Novi Put Plus” LLC Užice, with registered seat at the address 38 Nikole Pašića Street, Užice, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 21214302, created by executing a takeover of 100% of shares in “Novi Put Plus” LLC Užice, wherewith „MPP Jedinstvo“ JSC Sevojno acquires indirect control over “Novi Pazar – Put” JSC Novi Pazar, with registered seat at the address 67 Šabana Koče Street, Novi Pazar, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07195303.

II IT IS ESTABLISHED that the applicant of Notification has executed payment in the amount of RSD 1,869,981.05 (in words: one million, eight hundred sixty-nine thousand, nine hundred eighty-one and five hundredths Dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, reference number 6/0-02-595/2016-1, which represents determined amount

of the fee as compensation for issuing decision on approval of concentration in summary procedure.
