Pursuant to Article 37(2) of the Law on Protection of Competition ("Official Gazette of the RS", nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure ("Official Gazette of the FRY", nos. 33/97, 31/01 and "Official Gazette of the RS", no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition ("Official Gazette of the RS", no. 49/11), deciding under the notification on concentration entered under number 6/0-02-375/2016-1, submitted on May 4, 2016 by company Robert Bosch LLC with registered seat in Germany at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, company registration number HRB 14000, represented by plenipotentiary attorney Srđana Petronijević from the Law office "Moravčević, Vojnović i Parneri", with registered seat at the address 15 Dobračina Street, Belgrade, on June 16, 2016, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-474/2016-1 of June 14, 2016, enacts the following

DECISION

- I Concentration of undertakings in summary procedure **IS APPROVED** created in a manner where company Robert Bosch LLC with registered seat at the address Robert-Bosch Platz 1, 70839 Gerlingen-Schillerhöhe, Federal Republic of Germany, company registration number HRB 14000, via its affiliated company Robert Bosch Investment Nederland Pvt. Ltd., with registered seat at the address Kruisbroeksestraat 1, Boxtel, the Netherlands, company registration number HRB 34166287, will acquire 100% of shares in company BTS LLC, with registered seat at the address Prosta 21, 72-100 Lozienica, Poland, company registration number 810453743.
- II IT IS ESTABLISHED that company Robert Bosch LLC with registered seat in Germany at the address Robert-Bosch Platz 1, 70839 Gerlingen-Schillerhöhe, has fully performed against its obligation related to paying determined amount of the fee as compensation for issuing this decision, by executing payment in the amount of RSD 3,083,777.50 (in words: three million, eighty-three thousand, seven hundred seventy-seven and five tenths Dinars) to the account of the Commission for Protection of Competition maintained with the National Bank of

Serbia, which represents determined Dinar-currency equivalent amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
