Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-486/2017-1 of July 10, 2017, submitted on the part of company Knez Petrol Zemun LLC Beograd, with registered seat at the address 28 Carice Jelene St., Zemun, Belgrade, Serbia, company registration number 17535439, via company’s legal representative Sava Knežević, Managing Director, 28 Carice Jelene St., Zemun, Belgrade, on September 7, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company Knez Petrol Zemun LLC Beograd, with registered seat at the address 28 Carice Jelene St., Zemun, Belgrade, Serbia, company registration number 17535439, over parts of other undertaking, company Bobar Beška LLC Novi Sad, with registered seat at the address 9 Branka Bajića St., Novi Sad, company registration number 08814929, whose parts may represent independent business entities, specifically over the following petrol stations: 1. petrol station in Sonta, 1 Jovana Jovanovića Zmaja St., on the cadastral plot number 32/3 of the Cadastral municipality of Sonta with the total surface area of 572 m², entered into real estate folio in the land register under number 3538 of the CM of Sonta; 2. petrol station in Golubinci, bb Putnička St., on the cadastral plot number 9496/2 of the Cadastral municipality of Golubinci with the total surface area of 281 m², entered into real estate folio in the land register under number 5226 of the CM of Golubinci, and 3. petrol station in Ruski Kustur, 216 Maršala Tita St., on the cadastral plot number 5500 of the Cadastral municipality of Ruski Kustur with the total surface area of 289 m², entered into real estate folio in the land register under number 255 of the CM of Ruski Kustur.

II IT IS ESTABLISHED that the applicant of notification, company Knez Petrol Zemun LLC Beograd, with registered seat at the address 28 Carice Jelene St., Zemun, Belgrade, Serbia, has executed payment in the amount of RSD 2,981,767.25 (in words: two million, nine hundred eighty-one thousand, seven hundred sixty-seven and 25/100 dinars) to the account of the Commission for Protection of Competition, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
