Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-462/2017-1 of June 27, 2017, submitted by company Robert Bosch GmbH, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Federal Republic of Germany, registered in the Commercial Register B of the Basic Court in Stuttgart under company registration number HRB 14000, via plenipotentiary attorney Srđana Petronijević from the Law office Moravčević, Vojnović & partneri Beograd, 15 Dobračina Street, Belgrade, on July 25, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company Robert Bosch S.p.A., with registered seat in Italy at the address Via Petiti 15, Milan, registered in the Chamber of Commerce, Industry, Craft Trade and Agriculture of Milan under company registration number MI-174459, as a wholly owned subsidiary of company Robert Bosch GmbH, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Federal Republic of Germany, registered in the Commercial Register B of the Basic Court in Stuttgart under company registration number HRB 14000, over company M.T.A. S.p.A., with registered seat at the address Via Dell' Artigiano no. 2, 35026 Conselve (Padua), Italy, registered in the Chamber of Commerce, Industry, Craft Trade and Agriculture of Padua under company registration number PD-172171, created by the acquisition of the entire share capital of M.T.A. S.p.A. on the part of Robert Bosch S.p.A.

II IT IS ESTABLISHED that the applicant of notification, company Robert Bosch GmbH, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Federal Republic of Germany has executed payment via plenipotentiary

attorney in the amount of RSD 3,007,087.50 (in words: three million, seven thousand, eighty-seven and five tenths dinars) on July 18, 2017 to the account of the Commission for Protection of Competition, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
