Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (Official Gazette of the FRY 33/97 and 31/01, and Official Gazette of the RS 30/2010), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the Notification on concentration entered under number 6/0-02-717/2015-1 of September 28, 2015, submitted on behalf of company "Amcor Group" GmbH, with registered seat at the address Thurgauerstrasse 34, CH-8050, Zürich, Switzerland, registered in the Commercial Registry Office of the Canton of Zurich under company registration number CHE-115.290.037, and company "Sidel Participations" SAS, with registered seat at the address Avenue de la Patrouille de France, 76930 Octeville-sur-Mer, France, registered in the Trade and Companies Register maintained in the Commercial Court in Le Havre under company registration number 1965B00108, via attorney at law Bojana Miljanović from the Law Office "Karanović & Nikolić", 23 Resavska St., Belgrade, Republic of Serbia, on October 19, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by a joint venture comprised of companies "DISCMA" AG, with registered seat at the address Bösch 67, 6331 Hünenberg, Switzerland, company registration number CHE-263.708.034 and "LiquiForm Group LLC", with registered seat at the address 1300 Tefft Ct., Saline, MI 48176, USA, with the goal of creating a new undertaking which will be jointly managed by company "Amcor Group" GmbH, with registered seat at the address Thurgauerstrasse 34, CH-8050, Zürich, Switzerland, registered in the Commercial Registry Office of the Canton of Zurich under company registration number CHE-115.290.037, and company "Sidel Participations" SAS, with registered seat at the address Avenue de la Patrouille de France, 76930 Octeville-sur-Mer, France, registered in the Trade and Companies Register maintained in the Commercial Court in Le Havre under company registration number 1965B00108.

II IT IS ESTABLISHED that applicants of the Notification on concentration have executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-717/2015-1, which represents
