Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (Official Gazette of the FRY 33/97 and 31/01, and Official Gazette of the RS 30/2010), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-723/2015-1 of September 29, 2015, submitted on behalf of Limited liability company “UMKA Fabrika kartona Umka”, with registered seat at the address 1, 13. oktobra St., Umka, Belgrade-Čukarica, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07007019, via attorney at law Aleksandra Stojić from the Law Office “Dražić, Beatović & Stojić“ from Belgrade, 29 Kralja Milana St., on October 15, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of Limited liability company “UMKA Fabrika kartona Umka”, with registered seat at the address 1, 13. oktobra St., Umka, Belgrade-Čukarica, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07007019, over Joint stock company “Fabrika hartije Božo Tomić” – in liquidation, with registered seat at the address 18 Industrijski prolaz St., Čačak, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07182309, created pursuant to the instituted and implemented procedure of the sale of debtor as a legal entity via public collection of bids, and conclusion of the said procedure by announcing company “UMKA Fabrika kartona Umka” as a buyer of the target company in the sale by public tender.

II IT IS ESTABLISHED that company “UMKA Fabrika kartona Umka” as the applicant of the notification on concentration concerned, has performed on its obligation to pay a fee as a compensation for issuing this decision, by executing payment in the amount of RSD 2,995,910.00 (in words: two million, nine hundred ninety-five thousand, nine hundred ten and 00/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, with reference number 6/0-02-723/2015-1, which represents appropriate dinar-currency amount of the regulated fee as

compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition, calculated by implementing the middle exchange rate of the National Bank of Serbia on the day of payment.
