Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (Official Gazette of the FRY 33/97 and 31/01, and Official Gazette of the RS 30/2010), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-726/2015-1 of September 29, 2015 submitted by company Robert Bosch GmbH, with registered seat in Germany at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, company registration number HRB 14000, represented by attorney at law Srđana Petronijević from the Law Office „Moravčević, Vojnović & Partneri“, 15 Dobračina St., Belgrade, on October 26, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company Robert Bosch GmbH, with registered seat at the address Robert-Bosch Platz 1, 70839 Gerlingen-Schillerhöhe, Federal Republic of Germany, company registration number HRB 14000, over Kliklok group of companies, in a manner where Robert Bosch GmbH will via its subsidiary company Robert Bosch North America Corporation, company registration number 4271311, with registered seat at the address 2800 S. 25th Street, Broadview, Illinois 60155-4594, USA, will acquire 100% of shares in company Klikwood Holding Corporation, company registration number J812027, with registered seat at the address 5244 Snapfinger Woods Dr, Decatur Georgia 30035, USA, and indirect control over its subsidiary company Kliklok Woodman, company registration number J351747, with registered seat at the address 5244 Snapfinger Woods Dr, Decatur Georgia 30035, USA, while via its subsidiary company Bosch Packaging Technology Limited, company registration number 2632608, with registered seat at the address Unit 2a Meteor Business Park, Meteor Centre, Mansfield Road, Derby DE21 4SU, Great Britain, will acquire 100% of shares in company Kliklok International Limited, company registration number 835066, with registered seat at the address Western Drive, Hengrove Park Estate, Bristol BS14 0AY, Great Britain.

II IT IS ESTABLISHED that company Robert Bosch GmbH, with registered seat in Germany at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, has performed on its obligation on October 23, 2015, to pay a fee in the full amount as a compensation for issuing this

decision on approval of concentration in summary procedure, by executing payment in the amount of RSD 3,002,065.00 (in words: three million, two thousand, sixty-five and 00/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance no. 840-000000880668-16, with reference number 6/0-02-726/2015-1.
