Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification on concentration entered under number 6/0-02-629/2017-1 of October 2, 2017, submitted by companies: Company for foreign and domestic trade and services Nelt Co d.o.o. Dobanovci, with registered seat at the address 206 Maršala Tita St., Dobanovci, Belgrade, Republic of Serbia, company registration number 17304712, and company Alkemy SEE d.o.o. Beograd-Vračar, with registered seat at the address 64 Sime Igumanova St., Vračar, Belgrade, Republic of Serbia, company registration number 21240052, via attorney at law Goran Vučić from the Law Office of Joksović, Stojanović i partneri, 38 Internacionalnih brigada St., Belgrade, on October 27, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by a joint venture of companies: Company for foreign and domestic trade and services Nelt Co d.o.o. Dobanovci, with registered seat at the address 206 Maršala Tita St., Dobanovci, Belgrade, Republic of Serbia, company registration number 17304712, and company Alkemy SEE d.o.o. Beograd-Vračar, with registered seat at the address 64 Sime Igumanova St., Vračar, Belgrade, Republic of Serbia, company registration number 21240052, with the goal of creating a new undertaking operating on a long-term basis and holding all functions of an independent undertaking, whereas the new undertaking will acquire direct control over Company for Internet trade Tako Lako Shop d.o.o. Dobanovci, with registered seat at the address 206 Maršala Tita St., Dobanovci, Belgrade, Republic of Serbia, company registration number 21121720, by transferring 100% of shares from the previous sole shareholder, company Nelt Co d.o.o. Dobanovci, thereafter companies Alkemy SEE d.o.o. Beograd-Vračar and Nelt Co d.o.o. Dobanovci will own 51% and 49% of shares, respectively.

II IT IS ESTABLISHED that the applicant of notification, company Nelt Co d.o.o. Dobanovci, with registered seat at the address 206 Maršala Tita St., Dobanovci, Belgrade, has executed payment in the amount of RSD 2,985,077.50 (in words: two million, nine hundred eighty-five thousand, seventy-seven and 50/100 dinars) on October 25, 2017, to the account of the

Commission for Protection of Competition, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
