Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-139/2015-1, submitted by company Adriatic BidCo B.V., with registered seat in the Netherlands at the address Prins Bernhardplein 200, 1097 JB Amsterdam, represented by Bojan Vučković and other attorneys at law from the Law Office Karanović&Nikolić from Belgrade, 23 Resavska St., on March 5, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct exclusive control on the part of company Adriatic BidCo B.V., with registered seat in the Netherlands at the address Prins Bernhardplein 200, 1097 JB Amsterdam, registered in the Business Register maintained by the Netherlands Chamber of Commerce under company registration number 61264210, over company Danube foods group B.V., with registered seat in the Netherlands at the address Herikerbergweg 238, Luna Arena, 1101 CM Amsterdam Zuidoost, registered in the Business Register maintained by the Netherlands Chamber of Commerce under company registration number 34180508, and over company Clates Holding B.V., with registered seat at in the Netherlands at the address Herikerbergweg 238, Luna Arena, 1101 CM Amsterdam Zuidoost, registered in the Business Register maintained by the Netherlands Chamber of Commerce under company registration number 30223022, wherewith acquires indirect exclusive control over their subsidiaries, by acquiring 100% of shares.

II IT IS ESTABLISHED that company Adriatic BidCo B.V., with registered seat in the Netherlands at the address Prins Bernhardplein 200, 1097 JB Amsterdam, has executed payment of the regulated amount of fee in the full amount as compensation for issuing this decision on approval of concentration in summary procedure on February 20, 2015, by paying the amount of RSD 3,030,102.50 (in words: three million, thirty thousand, one hundred two and 50/100 dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, which represents dinar-currency equivalent value of EUR 25,000.00 (in words: twenty-five thousand euro) calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
