Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-195/2015-1 of February 18, 2015, submitted on behalf of client - company "Robert Bosch GmbH", with company registration number HRB 14000 and registered seat in at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Federal Republic of Germany, in accordance with the presented Power of attorney by attorney at law Srđana Petronijević from Belgrade, 15 Dobračina St., on March 24, 2015, President of the Commission for Protection of Competition enacts the following

DECISIO

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company "Robert Bosch GmbH", with company registration number HRB 14000 and registered seat in at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Federal Republic of Germany, over company „Osgood Industries“ Inc., with registered seat at the address 601 Burbank Road Oldsmar, FL. 34677, USA, company registration number P11000085828, where the indirect acquirer of control establishes related control via its subsidiary company in [...] ownership - „Robert Bosch North America Corporation“, which pursuant to the Agreement for purchase and sale of shares of February 6, 2015, acquires 100% of shares in company „Osgood Industries“ Inc. from its previous shareholders, where as a part of the transaction concerned, company „Osgood Industries“ Inc., – pursuant to the Real estate purchase and sale agreement concluded on February 6, 2015, will on the same day acquire a property located at the address 601 Burbank Road Oldsmar, Florida, USA, by purchasing the subject of acquisition from company „Muellco Partners“ LLC, as a previous owner of the property concerned.

II IT IS ESTABLISHED that the applicant has in timely manner executed payment in the amount of RSD 3,012,925.00 (in words: three million, twelve thousand, nine hundred twenty-five and 00/100 dinars) to the account of the Commission for Protection of Competition no. 840-880668-16, maintained with the Treasury Administration of the Ministry of Finance of the Republic

of Serbia, which represents appropriate dinar-currency equivalent value of the regulated amount of fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
