Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification on concentration entered under number 6/0-02-236/2015-1 of March 6, 2015, submitted on behalf of client – company „DS Smith PLC“, registered in the United Kingdom of Great Britain and Northern Ireland under company registration number 01377658, with registered seat at the address 350 Euston Road, Regent's Place, NW13AX London, Great Britain, in accordance with the presented Power of attorney by attorney at law Maja Stanković from the Law Office „Wolf Theiss“, BC Ušće, 6 Mihaila Pupina Boulevard, Belgrade – New Belgrade, on April 6, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company „DS Smith PLC“, registered in the United Kingdom of Great Britain and Northern Ireland under company registration number 01377658, with registered seat at the address 350 Euston Road, Regent's Place, NW13AX London, Great Britain, via its subsidiary companies „DS Smith Packaging Belita B.V.“, registered in the Business Register maintained by the Netherlands Chamber of Commerce under company registration number 08053543, with registered seat at the address Harderwijkerweg 41, 6961 Eerbeek, Kingdom of the Netherlands, and „DS Smith Austria Holdings GmbH“, registered in the Austrian Business Register under company registration number FN 397083x, with registered seat at the address Heidestrasse 15, 2433 Margarethen am Moos, Republic of Austria, over company „Duropack GmbH“, registered in the Business Register maintained by the Commercial Court in Vienna under company registration number FN 53708h, with registered seat at the address Brunner Strasse 75, 1230 Vienna, Republic of Austria, created by purchasing the entire capital stock of this company from its previous shareholders, with concurrent establishment of indirect control over all its subsidiaries.

II IT IS ESTABLISHED that the applicant has in timely manner executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-236/2015-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
