Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-351/2015-1 of April 22, 2015, submitted on behalf of company „Arriva dolenska in primorska, družba za prevoz potnikov“ d.o.o., founded in accordance with the legislation of the Republic of Slovenia, with registered seat at the address Kolodvorska cesta 11, 6000 Koper – Kapodistria, Slovenia, and registered in the Slovenian Business Register under company registration number 5352657000, by attorneys at law Miroslav Stojanović, Maja Stanković, Marina Bulatović and Igor Nikolić, all from the Law Office Wolf Theiss, BC Ušće, 6 Mihajla Pupina Boulevard, 11070 New Belgrade, Republic of Serbia, on May 13, 2015, President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company “Arriva dolenska in primorska, družba za prevoz potnikov“ d.o.o., founded in accordance with the legislation of the Republic of Slovenia, with registered seat at the address Kolodvorska cesta 11, 6000 Koper – Kapodistria, Slovenia, and registered in the Slovenian Business Register under company registration number 5352657000, over company „Alpetour putovalna agencija“ d.d., founded in accordance with the legislation of Slovenia, with registered seat at the address 8 Mirka Vadnova St., 4000 Kranj, Slovenia, registered in the Slovenian Business Register under company registration number 5097053000, created pursuant to the contractual takeover offer of minimum 59.21% of shares in company „Alpetour putovalna agencija“ d.d., wherewith company „Arriva dolenska in primorska, družba za prevoz potnikov“ d.o.o. as their buyer and acquirer establishes a direct control over this company, as well as indirect control over all its affiliated parties, all of which are from the Republic of Slovenia.

**II IT IS ESTABLISHED** that the applicant has in timely manner executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of

compensations for activities within the competence of the Commission for Protection of Competition.
