Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/2009 and 95/2013, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-808/2014-1 of December 22, 2014, submitted on behalf of company „Telenor ASA“, with registered seat at the address Snarøyveien 30, N-1331 Fornebu, Kingdom of Norway, registered in the Registration Center Brønnøysund under company registration number 982463718, and company „TeliaSonera AB“, with registered seat at the address Stureplan 8, SE-106 63 Stockholm, Kingdom of Sweden, registered in the Bolagsverket Registry under company registration number 556103-4249, in accordance with the presented Power of Attorney by Bojan Vučković, attorney at law from the Law Office „Karanović & Nikolić“ from Belgrade, 23 Resavska St., on February 9, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company „Telenor ASA“, with registered seat at the address Snarøyveien 30, N-1331 Fornebu, Kingdom of Norway, registered in the Registration Center Brønnøysund under company registration number 982463718, and company „TeliaSonera AB“, with registered seat at the address Stureplan 8, SE-106 63 Stockholm, Kingdom of Sweden, registered in the Bolagsverket Registry under company registration number 556103-4249, over a newly-founded company in Denmark that will operate under joint control of its founders and have all functions of an independent undertaking within the meaning of Article 17(1/3) of the Law.

II IT IS ESTABLISHED that applicants have in timely manner executed payment in the amount of EUR 24,973.00 (in words: twenty-four thousand, nine hundred seventy-three and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and amount of RSD 3,291.18 (in words: three thousand, two hundred ninety-one and 18/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, with reference number 6/0-02-808/2014, which in total represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
