Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the Notification on concentration entered under number 6/0-02-404/2015-1 of May 14, 2015, submitted on behalf of company "JT International Holding B.V.", with registered seat at the address Bella Donna 4, 1181RM, Amstelveen, the Netherlands, company registration number 32073749, in accordance with the submitted Power of attorney by Srđana Petronijević, attorney at law from the Law Office "Moravčević Vojnović i Partneri", 15 Dobračina St., Belgrade, Republic of Serbia, on June 12, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company "JT International Holding B.V.", with registered seat at the address Bella Donna 4, 1181RM, Amstelveen, the Netherlands, company registration number 32073749, over company "Logic Technology Development LLC", with registered seat at the address Pompano Business Center, 2004 NW 25th Avenue, Pompano Beach, Florida, USA, company registration number L13000174847, in a manner where "JT International Holding B.V." will via its affiliated companies "JTI (US) Holding Inc.", with registered seat at the address 2711, Suite 400, Centerville Road, Wilmington, County of New Castle, DE, 19808, USA, company registration number 32-0285484, and [...] ¹ will acquire [...] of shares and [...].

II IT IS ESTABLISHED that the applicant of notification has executed payment in the amount of EUR 24,975.50 (in words: twenty-four thousand, nine hundred seventy-five and 50/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and RSD 2,955.54 (in words: two thousand, nine hundred fifty-five and 54/100 dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance no. 840-000000880668-16, with reference number 6/0-02-404/2015-1, which in total represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
