Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the notification on concentration entered under number 6/0-02-510/2015-1 of June 23, 2015, submitted by company TELEKOM AUSTRIA AG, registered in the Commercial Court in Vienna under company registration number FN 144477 t, with registered seat at the address 1020 Vienna, Lassallestasse 9, Republic of Austria, via attorney at law Raško Radovanović from the Law Office of Petrikić & Partneri, Belgrade, 3 Cincar Jankova St., on July 21, 2015, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-554/2015-1 of July 15, 2015, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct individual control on the part of company TELEKOM AUSTRIA AG, joint stock company founded and operative in accordance with the legislation of the Republic of Austria, with registered seat at the address 1020 Vienna, Lassallestasse 9, Republic of Austria, registered in the Commercial Court in Vienna under company registration number FN 144477 t, over AMISCO NV, company founded and operative in accordance with the legislation of Belgium, with registered seat at the address Romeinsesteenweg 566, Bus 301, 1853 Strombeek-Bever, Belgium, registered in the Register of legal entities under company registration number 0882.011.793, created by purchasing 100% of shares from previous owner, company AMISCO NV, wherewith acquiring a control over the entire Amisco Group of companies.

II IT IS ESTABLISHED that the applicant of notification on concentration has executed payment in the amount of EUR 24,955.00 (in words: twenty-four thousand, nine hundred fifty-five and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and RSD 5,427.19 (in words: five thousand, four hundred twenty-seven and 19/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance

of the Republic of Serbia, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
