Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-655/2017-1, submitted by company Atos S.E., with registered seat in France at the address 80 Quai Voltaire, 9580 Bezons, represented by attorney at law Srđana Petronjević from the Law Office „Moravčević Vojnović & Partneri“ from Belgrade, 15 Dobračina St., on November 10, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual indirect control on the part of company Atos S.E., with registered seat in France at the address 80 Quai Voltaire, 9580 Bezons, registered in the Corporate Register in Pontoise under company registration number 323 623 603 R.C.S., via its subsidiary as a direct acquirer of control, company Atos International B.V., with registered seat in the Netherlands at the address Burgermeester Rijnderslaan 30, 1185 MC Amstelveen, company registration number 804586366, over company Siemens Convergence Creators Holding GmbH, with registered seat in Austria at the address Autokaderstraße 29, 1210 Vienna, registered in the Commercial Court in Vienna under company registration number FN 377995a, by acquiring 100% of share interests, as well as over business operations and assets of company Siemens Ltd. Beijing, China, both subsidiaries of company Siemens AG, with registered seat in Munich and Berlin, Germany, whose registered office is at the address Werner-von Siemens Strasse 1, 80333 Munich.

II IT IS ESTABLISHED that company Atos S.E., with registered seat in France at the address 80 Quai Voltaire, 9580 Bezons, has properly executed payment as regulated amount of compensation for issuing this decision on November 7, 2017, in the amount RSD 2,965,060.00 (in words: two million, nine hundred sixty-five thousand, sixty dinars) to the account of the Commission for Protection of Competition, which represents dinar-currency equivalent value of EUR 25,000.00 (in words: twenty-five thousand euro) calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
