Inobanba-cho, Nishinosho, Kisshoin, Minamai-ku, Kyoto, 601-8520 Japan, registered in the Kyoto District Legal Affairs Bureau under corporate number 1300-01-028411, and company Mitsubishi Corporation, with registered seat at the address 3-1 Marunouchi 2-chome, Chiyoda-ku, Tokyo 100-8086 Japan, registered in the Tokyo Legal Affairs Bureau under corporate number 0100-01-008771, pursuant to the presented Power of attorney by Srđana Petronijević, attorney at law from the Law Office „Moravčević, Vojnović & Partneri“ from Belgrade, 27 Francuska St., on May 24, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-1 of April 30, 2013, enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by incorporation of a joint venture company on the part of company „Robert Bosch GmbH“, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhohe, Germany, registered in the Basic Court in Stuttgart under company number HRB 14000, company GS Yuasa International Ltd, with registered seat at the address 1. Inobanba-cho, Nishinosho, Kisshoin, Minamai-ku, Kyoto, 601-8520 Japan, registered in the Kyoto District Legal Affairs Bureau under corporate number 1300-01-028411, and company Mitsubishi Corporation, with registered seat at the address 3-1 Marunouchi 2-chome, Chiyoda-ku, Tokyo 100-8086 Japan, registered in the Tokyo Legal Affairs Bureau under corporate number 0100-01-008771.

**II IT IS ESTABLISHED** that the Parties in timely manner executed full payment in the amount of RSD 2,773,820.00 (in words: two million, seven hundred seventy-three thousand, eight hundred twenty and 00/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance and Economy, which represents appropriate dinar-currency value of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
