Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the Notification of concentration entered under number 6/0-02-478/2013-1 of July 4, 2013, submitted on behalf of the client, company „Pinnacle Holdco Parent, Inc.“, with registered seat in the State of Delaware at the postal address: The Corporation Trust Company, 1209 Orange Street, Wilmington, New Castle County, Delaware 19801, United States of America, pursuant to the presented Special power of attorney of June 26, 2013 by attorneys at law Maja Stanković and Marina Bulatović from the Law Office Wolf Theiss, BC Ušće, 6 Mihajla Pupina Blvd., Belgrade, on August 1, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-5 of May 29, 2013, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control over company „Pra Holdings, Inc.“, with registered seat in the State of Delaware at the postal address The Corporation Trust Company, Corporation Trust Center, 1209 Orange Street, City of Wilmington, County of New Castle, 19801, Delaware, United States of America, established by company „Pinnacle Holdco Parent, Inc.“, with registered seat in the State of Delaware at the postal address: The Corporation Trust Company, 1209 Orange Street, Wilmington, New Castle County, Delaware 19801, United States of America, via its wholly owned subsidiary company „Pinnacle Merger Sub, Inc.“, with registered seat at the identical address, created pursuant to the Merger agreement between companies „Pinnacle Merger Sub, Inc.“ and „Pra Holdings, Inc.“, followed by „Pinnacle Holdco Parent, Inc.” acquisition of all shares in company „Pra Holdings, Inc.“, which will continue to operate as a wholly owned subsidiary of company „Pinnacle Holdco Parent, Inc.“.

II IT IS ESTABLISHED that the Party in timely manner executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-478/2013-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
