Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (Official Gazette of the FRY 33/97 and 31/01, and Official Gazette of the RS 30/2010), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under the reception number 6/0-02-605/2015-1 of August 11, 2015, submitted on behalf of Joint stock company „Mobitel EAD“, founded and operative in accordance with the legislation of Bulgaria, with registered seat at the address 1 Kukuš St., Sofia, Bulgaria, registered under company registration number 131468980, via attorney at law Anja Tasić from the Law Office of Petrikić & Partneri from Belgrade, 3 Cincar Jankova St., on September 8, 2015, President of the Commission for Protection of Competition enacts the following

**DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct individual control on the part of Joint stock company „Mobitel EAD“, founded and operative in accordance with the legislation of Bulgaria, with registered seat at the address 1 Kukuš St., Sofia, Bulgaria, registered under company registration number 131468980, over company „Bultel Cable Bulgaria EAD“, founded and operative in accordance with the legislation of Bulgaria, with registered seat at the address 1700 Sofia, Studentski grad, 83 Nikola Gabrovski Boulevard, Bulgaria, registered under company registration number 200883610, created pursuant to the Sale and purchase agreement concluded on July 29, 2015, regulating that company „Mobitel EAD“ by purchasing 100% of share interests in company „Bultel Cable Bulgaria EAD“ from its previous owner shall become a sole shareholder in the said company, wherewith establishing the exclusive and direct control over the said company, as well as establishing the indirect individual control over companies operating within the same group of companies controlled by „Bultel Cable Bulgaria EAD“.

**II IT IS ESTABLISHED** that Joint stock company „Mobitel EAD“ with registered seat in Sofia, Bulgaria, has fully performed on its obligation related to paying determined amount of the fee as compensation for issuing this decision, by executing payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia with reference number 6/0-02-605/2015-1, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
