Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the Notification of concentration entered under number 6/0-02-475/2018-1 of June 12, 2018, submitted by company AL Sirona (Luxembourg) Acquisition S.à r.l., with registered seat at the address 2-4 Rue Beck, 1222, Luxembourg, via procurator holder, attorney at law Bojana Miljanović from the Law Office of Nikolić/Karanović from Belgrade, 23 Resavska St., on July 10, 2018, the President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company AL Sirona (Luxembourg) Acquisition S.à r.l., with registered seat at the address 2-4 Rue Beck, 1222, Luxembourg, registered in the Luxembourg Company Register under company number B223382, **over Zentiva group of companies**, composed of the following legal entities as subjects of this merger:

**II IT IS ESTABLISHED** that the Party, AL Sirona (Luxembourg) Acquisition S.à r.l., with registered seat at the address 2-4 Rue Beck, 1222, Luxembourg, has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) on June 15, 2018, to the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
