Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-722/2018-1 of October 12, 2018, submitted by company „AL DAHRA AGRICULTURE“ LLC, with registered seat at the address 7th floor, Al Ain Tower, Khalidiya, PO Box 130455, Abu Dhabi, United Arab Emirates, via procurator holder, attorney at law Ana Banićević, 6 Mihajla Pupina Blvd., Belgrade, on November 2, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company „AL DAHRA AGRICULTURE“ LLC, with registered seat at the address 7th floor, Al Ain Tower, Khalidiya, PO Box 130455, Abu Dhabi, United Arab Emirates, company number CR-1131742, over the assets of company „POLJOPRIVREDNA KORPORACIJA BEOGRAD AD“, with registered seat at the address bb Industrijsko naselje St., Padinska Skela, company number 07042230, and its following subsidiary companies: 1) „EKO-LAB DRUŠTVO SA OGRANIČENOM ODGOVORNOŠĆU ZA UPRAVLJANJE KVALITETOM“, with registered seat at the address Padinska Skela, Belgrade, company number 07783582, 2) „PKB AGROEKONOMIK DRUŠTVO SA OGRANIČENOM ODGOVORNOŠĆU – INSTITUT ZA NAUČNOISTRAŽIVAČKI RAD I TRANSFER TEHNOLOGIJE U POLJOPRIVREDI“, with registered seat at the address bb Insustijsko naselje St., Padinska Skela, Belgrade, company number 07783647, and 3) „VETERINARSKA STANICA PKB“ d.o.o., with registered seat at the address bb Insustijsko naselje St., Padinska Skela, Belgrade, company number 20150211, executed by acquiring shares.

II IT IS ESTABLISHED that the Party, company „AL DAHRA AGRICULTURE“ LLC, has executed payment in the amount of RSD 2,958,377.50 (in words: two million, nine hundred fifty-eight thousand, three hundred seventy-seven and 50/100 dinars) on October 18, 2018, to the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
