Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-794/2018-1 of November 13, 2018, submitted by company Budamar Logistics a.s., with registered seat at the address Horárska 12, 821 09 Bratislava, Slovakia, via procuration holder, attorney at law Dragan Gajin from the Law Office “Doklešić i partneri” from Belgrade, 203 Oslobođenja Blvd., on November 30, 2018, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by the acquisition of joint control on the part of companies Budamar Logistics a.s., with registered seat at the address Horárska 12, 821 09 Bratislava, Slovakia, company number 35 736 046, and Optifin Invest s.r.o., with registered seat at the address Rusovská cesta 1, 851 01 Bratislava, Slovakia, company number 35 735 457, over company ELH Waggonbau Niesky GmbH, with registered seat at the address Am Waggonbau 1, Niesky, Germany, company number HRB 37285, which is established in a manner where company Budamar Logistics a. s. is purchasing 50% of shares in the said target company from the previous holder of full ownership rights, company Optifin Invest s.r.o., and where the two companies are continuing to exercise the joint control following the target company’s merger with companies ELH Eisenbahnlaufwerke Halle GmbH & Co. KG, with registered seat at the address H.-D.-Genscher-Straße 34, Landsberg, Germany, company number HRA 32047, and ELH Eisenbahnlaufwerke Halle Verwaltungs GmbH, with registered seat at the address H.-D.-Genscher- Straße 34, Landsberg, Germany, company number HRB 211503, which will continue to operate following the merger under the business name ELH Waggonbau Niesky GmbH.

II IT IS ESTABLISHED that company Optifin Invest s.r.o., has executed payment in the amount of EUR 12,461.00 (in words: twelve thousand, four hundred sixty-one and 00/100 euro) on November 14, 2018, and that company Budamar Logistics a. s. has executed payment in the amount of EUR 12,500.00 (in words: twelve thousand, five hundred and 00/100 euro), and the amount of

RSD 4,610.42 (in words: four thousand, six hundred ten and 42/100 dinars), both on November 19, 2018, where the latter corresponds to the dinar-currency equivalent value of EUR 39,00 (in words: thirty-nine euro) calculated at the middle exchange rate of the National Bank of Serbia on the day of payment, to the account of the Commission for Protection of Competition, which in total represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
