Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-177/2017-1, submitted on January 30, 2017 by Daxcom LLC, with registered seat at the address Stadsgården 10, SE-116 45 Stockholm, Kingdom of Sweden, registered in the Business Registers Agency of Sweden – Bolagsverket under company registration number 556922-8850, via plenipotentiary, attorney Bojana Miljanović from the Law office “Kranović/Nikolić” a.o.d., with registered seat at the address 23 Resavska Street, Belgrade, on February 24, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct individual control on the part of Daxcom LLC, with registered seat at the address Stadsgården 10, SE-116 45 Stockholm, Kingdom of Sweden, registered in the Business Registers Agency of Sweden – Bolagsverket under company registration number 556922-8850, and thus of indirect individual control on the part of company Telenor JSC, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, company registration number 982 463 718, over company Avstampet Dec 2740 LLC, with registered seat at the address Box 69, 851 02 Sundsvall, Kingdom of Sweden, registered in the Business Registers Agency of Sweden – Bolagsverket under company registration number 559093-7628, by acquiring 100% of shares in this company, which shall change the company name into Network Services Sweden LLC.

II IT IS ESTABLISHED that the applicant of notification has executed the payment in the amount of EUR 24,975.00 (in words: twenty-four thousand, nine hundred seventy-five Euro) on February 6, 2017, and amount of EUR 3,098.10 (in words: three thousand, ninety-eight and one tenth Euro) on February 24, 2017, to the foreign-currency account of the Commission for

Protection of Competition maintained with the National Bank of Serbia, which represents determined amount of the fee as compensation for issuing the decision on approval of concentration in summary procedure.
