Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-833/2018-1 of November 26, 2018, submitted by company Harveast Holding Limited, with registered seat at the address Themistokli Dervi, 3 Julia House 1066, Nicosia, Cyprus, via procurator holder, attorney at law Zorica D. Stevanović from Belgrade, 14 Beogradska St., on December 17, 2018, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct individual control on the part of company Harveast Holding Limited, company number 281502, with registered seat at the address Themistokli Dervi, 3 Julia House 1066, Nicosia, Cyprus, over company Agrotime Invest Limited, company number 386009, with registered seat at the address Metochiou 37, Agios Andreas, 1101 Nicosia, Cyprus, thereby also acquiring the indirect control over company Agrotime Holding MC, company number 34575937, with registered seat at the address 1 Pohrebniaka Street, Chubynske Village, Boryspil District, Kyiv Oblast 08321, Ukraine, and its subsidiaries:

-Borodianske Grain Reception Enterprise, company number 30535885, with registered seat at the address 42 Pryvokazalna Street, Borodianka Village, Borodianka District, Kyiv Oblast 07800, Ukraine, and

-Trading House Agrarian Union, with registered seat at the address, 1/1 Kyivska Street, Byshiv Village, Makariv District, Kyiv Oblast 08072, Ukraine, created by purchasing shares.

II IT IS ESTABLISHED that the Party, Harveast Holding Limited, company number 281502, with registered seat at the address Themistokli Dervi, 3 Julia House 1066, Nicosia, Cyprus, has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) on November 27, 2018, to the account of the Commission for Protection of Competition, which

represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
