Rationale

Based on the Conclusion no. 4/0-02-366/2018-1 of April 24, 2018, enacted by the Commission President, the Commission for Protection of Competition has instituted proceedings *ex officio* against undertakings PREDUZEĆE ZA PROIZVODNJU, PROMET I USLUGE KEPROM DOO, BEOGRAD (ZEMUN) (hereinafter: Keprom), and SAMOSTALNA TRGOVINSKO KOMISIONA RADNJA-BEBI BUTIK RODA AVRAMOVIĆ RADE PREDUZETNIK BEOGRAD (ZVEZDARA) (hereinafter: STKR Roda) in order to investigate the infringement of competition from Article 10 of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/2013, hereinafter: the Law). Namely, the Commission for Protection of Competition (hereinafter: the Commission) has reasonably assumed that Keprom and STKR Roda, as the seller and the buyer respectively, have established the sale prices and other conditions of trade on the baby care products retail market.

Based on facts beyond a reasonable doubt on the existence of objective risks of removal or alteration of evidence in the possession of Keprom, as well as based on a reasonable assumption that Keprom is implementing the identical business, and in particular price policy in respect of other buyers as well, the Commission has conducted a dawn raid on April 24, 2018 on the business premises of company Keprom, based on the Conclusion on the implementation of dawn raid, no. 4/0-02-366/2018-5 of April 24, 2018.

During the dawn raid, the Commission has found agreements named “General Purchase and Sale Agreements”, entered into by Keprom as the seller with its buyers. The agreements are temporary seized, based on the Conclusion no. 4/0-02-366/2018-8 of April 24, 2018, and constitute the Annex I to the Minutes on the implementation of dawn raid on the business premises of company Keprom doo Beograd, no. 4/0-02-366/2018-7 of April 24, 2018. The agreements entered into by Keprom with the Parties (hereinafter: Agreements) are presented in the table below.

By inquiring into the Agreements, it is established that they concern the standard contracts and that Article 2(2) therein stipulates the Buyer's commitment not to establish the resale price of products below the Seller's invoice price.

The provision of Article 10(1) of the Law stipulates the following: “Restrictive agreements are agreements between undertakings which as their purpose or effect have a significant restriction, distortion or prevention of competition in the territory of the Republic of Serbia.” In Article 10(2/1) is regulated that restrictive agreements may include contracts, certain contract provisions, express or tacit agreements, concerted practices, as well as decisions of undertakings associations, which in particular directly or indirectly set the purchase or selling prices or other conditions of trade.

Article 10(3) of the Law stipulates that restrictive agreements are prohibited and void, except in cases of exemption from the prohibition pursuant to the Law.

Following a comprehensive analysis of the agreements presented, the Commission has reasonably assumed that Keprom as a seller and other Parties as buyers have infringed the competition by setting the sale prices and other conditions of trade in individual agreements. The reasonable assumption is based on the fact that the agreement concerned contains provisions that establish the resale prices. The said provision restricts the buyer to autonomously and independently enact business decisions concerning the price policy.

In view of the assessment of the fulfilment of conditions from Article 35(1) of the Law for instituting *ex officio* proceedings for the investigation of competition infringement, pursuant to the provision of Article 35(2) of the Law, it is decided as in Paragraphs I and II of enacting terms herein.

Pursuant to the provision of Article 40(1) of the Law stipulating that conclusions on instituting *ex officio* proceedings are to be published in the Official Gazette of the Republic of Serbia and on the website of the Commission, it is decided as in Paragraph III of enacting terms herein.

Instruction on legal remedy:

This conclusion is not susceptible to special appeal, but is permitted to institute an administrative dispute by appealing to the Administrative Court against the final decision of the Commission.
