Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the Notification of concentration entered under number 6/0-02-903/2018-1 of December 24, 2018, jointly submitted by Predica Prevoyance Dialogue du Credit Agricole SA, with registered seat at the address 50-56 rue de la Procession, 75015, Paris, France, and La Chambre de commerce et d'industrie de region Paris Ile-de-France, with registered seat at the address 27 avenue de Friedland, F-75382, Paris, France, via procuration holder, attorney at law Maja Stanković from Belgrade, New Belgrade, 6 Mihajla Pupina Blvd., on January 24, 2019, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED**, created by acquisition of indirect joint control on the part of Predica Prevoyance Dialogue du Credit Agricole SA, company number 334 028 123, with registered seat at the address 50-56 rue de la Procession, 75015, Paris, France, and La Chambre de commerce et d'industrie de region Paris Ile-de-France, with registered seat at the address 27 avenue de Friedland, F-75382, Paris Cedex 08, Paris, France, via its subsidiary company La société Immobiliére du Palais des Congrès SA, company number 712 029 214, with registered seat at the address 2, Place de la Porte Maliot, 75017, Paris, France, over company Comete Holding SAS, company number 811 162 437, with registered seat at the address 70, Avenue du General de Gaulle, 92058 Paris La defense Cedex, Paris, France, and its operating subsidiary Comexposium Holding SA, company number 415 072 685, with registered seat at the address Immeuble, le Wilson, 70 Avenue du General de Gaulle, 92058 Paris La defense Cedex, Paris, France.

II IT IS ESTABLISHED that the Party, company Predica Prevoyance Dialogue du Credit Agricole SA, company number 334 028 123, has executed payment transaction in the amount of EUR 12,500.00 (in words: twelve thousand, five hundred euro) on January 15, 2019, and company La société Immobiliére du Palais des Congrès SA, company number 712 029 214, has executed payment transaction in the amount of EUR 12,456.00 (in words: twelve thousand, four hundred fifty-six euro) on January 16, 2019, and RSD 5,208.00 (in words: five thousand, two hundred eight dinars) on January 17, 2019, to the account of the Commission for Protection of

Competition, which represents a stipulated amount of the fee as compensation for issuing a decision on approval of concentration in summary procedure.
