Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the merger notification entered under number 6/0-02-728/2018-1 of October 16, 2018, submitted by company „Mondo Inc“ d.o.o., with registered seat at the address 4 Obilićev venac St., Belgrade, via procuration holder, attorney at law Stefan Antonić, 51b Radnička St., Belgrade, on December 5, 2018, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company „Mondo Inc“ d.o.o., with registered seat at the address 4 Obilićev venac St., Belgrade, company number 20729384, over company „Adria Media Group“ d.o.o., with registered seat at the address 8 Vljakovićeve St., Belgrade, company number 17572423, and over its subsidiaries as follows: 1) „Adria Media Magazine“ d.o.o., with registered seat at the address 8 Vljakovićeve St., Belgrade, company number 21136743, 2) „Adria Media Invest“ d.o.o., with registered seat at the address 8 Vljakovićeve St., Belgrade, company number 21136794, and its subsidiaries, 3) „Adria Media Zagreb“ d.o.o., with registered seat at the address 6h/1 Oreškovićeve St., Zagreb, Croatia, company number 080416877, as well over company „ADMATIC MEDIA“ d.o.o., with registered seat at the address 6a Vljakovićeve St., Belgrade, company number 21273163, by purchasing shares.

II IT IS ESTABLISHED that the party, company „Mondo Inc“ d.o.o., has made payment in the amount of RSD 826,088.62 (in words: eight hundred twenty-six thousand eighty-eight and 62/100 dinars) on October 17, 2018, and RSD 26,885.49 (in words: twenty-six thousand eight hundred eighty-five and 49/100 dinars) on November 14, 2018, into the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on the approval of concentration in summary procedure.
