Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding in proceedings initiated on receipt of a merger notification registered before the Commission under number 6/0-02-472/2019-1 of May 15, 2019, submitted by company Futura plus a.d. Beograd (Novi Beograd), with registered seat at the address 19 Milutina Milankovića St., Belgrade, represented by procurator holder, attorney at law Siniša Čolević from Novi Sad, 4/II Sremska St., on June 7, 2019, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct individual control on the part of company Futura plus a.d. Beograd (Novi Beograd), with registered seat at the address 19 Milutina Milankovića St., Belgrade, company number 17572130, over parts of other undertaking, company Vik invest d.o.o. Niš, with registered seat at the address 32 Dragiše Cvetkovića St., Niš, company number 20422769, whose parts may represent an independent business entity, namely over seven retail stores located in the territory of the City of Niš at the following addresses: 1) Cnr. Nikole Pašića & Obrenovićeve St., Municipality of Medijana; 2) bb Generala Milojka Lesjanina St., Municipality of Medijana; 3) Kej Kola srpskih sestara St., Municipality of Medijana; 4) bb Obilićev venac St., Municipality of Medijana; 5) 5 Svetozara Markovića St., Municipality of Medijana; 6) Cnr. Prvomajska & Vožda Karađorđa St., Municipality of Medijana; 7) Knjaževačka St. near RK Sinđelić, Municipality of Pantelej, as well as over one retail store located in the territory of the City of Pirot at the address Branka Radičevića St. near Intesa bank.

II **IT IS ESTABLISHED** that the party has made payment in the amount of RSD XXXXX on May 17, 2019, into the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on the approval of concentration in summary procedure.
