## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED**, created by acquisition of joint control on the part of company Carr Holdings Limited, with registered seat at the address Prodromou & Dimitrakopoulou 2, 1090 Nicosia, Cyprus, company registration number HE 396252, and natural persons Fadi Rida and Mihai Stanescu, both with residence in Bucharest, Romania, over companies Global Technical Services S.R.L., with registered seat at the address 26 Frunzei St., District 2, Bucharest, Romania, company registration number J40/3951/2012, Global Technical Systems S.R.L., with registered seat at the address 26 Frunzei St., District 2, Bucharest, Romania, company registration number J40/12586/2007, Global Operation Center S.R.L., with registered seat at the address 26 Frunzei St., Bucharest, Romania, company registration number J40/19030/2017, and GTS Global Intelligence S.R.L., with registered seat at the address 26 Frunzei St., Bucharest, Romania, company registration number J40/15257/2012, including their subsidiaries, by purchasing 70% of shares in each of the above listed companies by Carr Holdings Limited from the previous owners, natural persons Fadi Rida and Mihai Stanescu.
