Pursuant to Article 22(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/2) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding on a request made by companies HENKEL SRBIJA DOO BEOGRAD, with registered office at 383 Oslobođenja Blvd., Belgrade, whose legal representative is Gordana Brašić, CEO, and MD INTERNATIONAL DOO BEOGRAD, with registered office at 39 Žorža Klemansoa St., Belgrade, whose legal representative is Zlatko Cvetković, CEO, filed via joint procuration holder Bojan Vučković, attorney at law from the Law Office “Karanović & Partners”, 23 Resavska St., Belgrade, for the exemption of restrictive agreement from prohibition – Distribution Agreement, at the 220th session held on August 14, 2019, the Council of the Commission for Protection of Competition enacts the following

DECISION

I Restrictive agreement – Distribution Agreement, with accompanying annexes, **SHALL BE EXEMPT FROM PROHIBITION**, concluded between companies HENKEL SRBIJA DOO BEOGRAD, with registered office at 383 Oslobođenja Blvd., Belgrade, company number: 07102160, and MD INTERNATIONAL DOO BEOGRAD, with registered office at 39 Žorža Klemansoa St., Belgrade, company number: 17175122, filed under Reg. No. 6374/2019 of May 25, 2019, with company HENKEL SRBIJA DOO BEOGRAD, that is, Reg. No. 0190529-0007 of May 25, 2019, with company MD INTERNATIONAL DOO BEOGRAD, together with the Annex to the Agreement, filed under Reg. No. 7646/19 of June 28, 2019, with company HENKEL SRBIJA DOO BEOGRAD.

II TIME PERIOD SHALL BE DETERMINED, pertaining to the individual exemption from prohibition of the restrictive agreement referred to in Paragraph I of enacting terms herein, set to expire on May 25, 2020.

III Commitment SHALL BE ESTABLISHED and IT SHALL BE ORDERED to the Parties to compensate for the issuance of this decision in dinar-currency equivalent value of EUR 1,200.00, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment, paid into the account of the Commission for Protection of Competition No. 840-0000000880668-16 maintained with the Treasury Administration, reference number: 4/0–03–498/2018, no later than seven days from the date of receipt of this decision.

It is established that the Parties have executed payment in the amount of RSD 141,550.44 on April 9, 2019, thus have acted in line with their commitment on the basis the decision concerned.
