Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), on receipt of the merger notification No. 6/0-02-707/2019-1 of August 13, 2019, submitted by company Robert Bosch GmbH, with registered office at Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhöhe, Germany, represented by procurator holder, attorney at law Jelena Obradović from the Law Office “Moravčević Vojnović i partneri”, 15 Dobračina St., Belgrade, on September 3, 2019, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of joint control on the part of companies Robert Bosch GmbH, with registered office at Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhöhe, Germany, company number HRB 14000, and Gustav Magenwirth GmbH & Co. KG, with registered office at Stuttgarter Str. 48, 72574 Bad Urach, Germany, company number HRA 361077, over companies MAGURA Bike Parts GmbH & Co. KG, with registered office at Stuttgarter Str. 48, 72574 Bad Urach, Germany, company number HRA 360963, and MAGURA GmbH, with registered office at Stuttgarter Str. 48, 72574 Bad Urach, Germany, company number HRB 361171, resulting for the acquisition of 50% of shares by company Robert Bosch GmbH, with registered office at Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhöhe, Germany, company number HRB 14000, from company Gustav Magenwirth GmbH & Co. KG, with registered office at Stuttgarter Str. 48, 72574 Bad Urach, Germany, company number HRA 361077, as a former sole shareholder.
