## DECISION

**I** Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created in a joint venture arrangement between company Robert Bosch GmbH, with registered office at Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhöhe, Germany, company number HRB 14000, via its subsidiary company Bosch (Shanghai) Investment Consulting Limited Company, with registered office at Room 2001 G, 20<sup>th</sup> Floor, #28 Ma Ji Road, China (Shanghai) Pilot Free Trade Zone, People's Republic of China, company number 91310115324232182N, and company Gobi Chuangying (Shanghai) Venture Capital Management Co., Ltd., with registered office at Room 3439, Building 15, #36 Guohe Road, Huangpu District, Shanghai, People's Republic of China, company number 91310110579116239F, in order to create a new undertaking that will operate on a long-term basis and have all functions of an independent undertaking.
