Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the merger notification entered under number 6/0-02-385/2019-1 of April 8, 2019, submitted by company Generali CEE Holding B.V., with registered seat at the address De entree 91, 1101 BH, Amsterdam, the Netherlands, via procurator holder, attorney at law Srđana Petronijević from the Law Office „Moravčević, Vojnović i partneri“, 15 Dobračina St., Belgrade, on May 10, 2019, the President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company Generali CEE Holding B.V., with registered seat at the address De entree 91, 1101 BH, Amsterdam, the Netherlands, company number 34275688, via its subsidiary company Generali Biztosito Zrt, with registered seat at the address Terez krt. 42-44, 1066 Budapest, Hungary, company number Cg.01-10-041305, over the life insurance portfolio of company Ergo Eletbiztosito Zartkoruen Mukodo Reszvenytarsasag, with registered seat at the address Futo utca 47-53 4. em, 1082 Budapest, Hungary, company number Cg.01-10-044524, and over the non-life insurance portfolio of company Ergo Versicherung Aktiengesellschaft Magyarorszagi Fioktelepe, with registered seat at the address Futo utca 47-53 4. em, 1082 Budapest, Hungary, company number Cg. 01-17-000758, pursuant to the Insurance portfolio purchase agreements, as well via its other subsidiary company Generali Poistovna, a. s., with registered seat at the address Lamačska cesta 3/A, Bratislava, Slovakia, company number 35 709 332, over the life and non-life insurance portfolio of company Ergo Poistovna, a.s, with registered seat at the address Prievozska 4C, 821 08 Bratislava, Slovakia, company number 35 779 012, pursuant to the Memorandum of cooperation.

**II IT IS ESTABLISHED** that the party has made payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) on April 11, 2019, into the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on the approval of concentration in summary procedure.
