Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), in proceedings instituted on receipt of the merger notification No. 6/0-02-520/2020-1 of July 28, 2020, filed by companies DTEK OIL&GAS DEVELOPMENT B.V., with registered office at Strawinskylaan 1531, Tower B, Level 15, Amsterdam, the Netherlands, and CURZON COMMODITIES TRADING LIMITED, with registered office at 10 Brick Street, Mayfair, London, United Kingdom of Great Britain and Northern Ireland, W1J 7HQ, represented by procurator holder Maja Stanković and other attorneys at law from the Law Office "Wolf Theiss" from Belgrade, 6 Mihaila Pupina Blvd., on August 14, 2020, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of joint control on the part of companies DTEK OIL&GAS DEVELOPMENT B.V., with registered office at Strawinskylaan 1531, Tower B, Level 15, Amsterdam, the Netherlands, company registration number 63972735, and CURZON COMMODITIES TRADING LIMITED, with registered office at 10 Brick Street, Mayfair, London, United Kingdom of Great Britain and Northern Ireland, W1J 7HQ, company registration number 12217342, over companies LLC "NADRA SERVICE INVEST", with registered office at 6 Dragomanova St., App 4, 79005, Lviv, Ukraine, company registration number 41644312, LLC "NADRAPROSTIR", with registered office at 13A Zapadinska St., 04123, Kiev, Ukraine, company registration number 42673779, LLC "UNOLIT OIL", with registered office at 13A Zapadinska St., 04123, Kiev, Ukraine, company registration number 42673799, and LLC "VILENDA-RESOURCE 2000", with registered office at 18B Yuri Ilenka St., Office 211, 04050, Kiev, Ukraine, company registration number 41584484, by purchasing shares.

II IT SHALL BE ESTABLISHED that the notifying parties, companies DTEK OIL&GAS DEVELOPMENT B.V. and CURZON COMMODITIES TRADING LIMITED have made payment in the amount of XXX euro on July 31, 2020, and the amount of XXX dinars on August 4, 2020, into the account of the Commission for Protection of Competition, which in total represents the fee charged for issuing a merger clearance decision in summary procedure, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
