Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), in proceedings instituted on receipt of the Merger notification No. 6/0-02-909/2019-1 of November 20, 2019 filed by company G Distribution B.V., with registered seat at Amstelplein 1, Rembrandttoren, 1096 HA Amsterdam, the Netherlands, Romano Rossi, an Italian citizen residing in the Republic of Serbia at the address 2/4 Strahinjića Bana St., Belgrade, and Enrico Rossi, an Italian citizen residing in the Republic of Serbia at the address 3/A Boška Petrovića St., Belgrade, via procurator holder Srđan Dabetić and other attorneys at law from the Law Office Karanović i partneri oad from Belgrade, 23 Resavska St., on December 27, 2019 the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of joint control on the part of company G Distribution B.V., with registered seat at Amstelplein 1, Rembrandttoren, 1096 HA Amsterdam, the Netherlands, company registration number 57674264, Romano Rossi, an Italian citizen residing in the Republic of Serbia at the address 2/4 Strahinjića Bana St., Belgrade, and Enrico Rossi, an Italian citizen residing in the Republic of Serbia at the address 3/A Boška Petrovića St., Belgrade, over company F.LLI ROSSI SHOES d.o.o. Sombor, with registered office at 26 Ivana Milutinovića St., Sombor, Republic of Serbia, company number 21537683, to which the employees, right to use, equipment, and licensees of a facility for the production of footwear and uppers are transferred, located in the City of Sombor, Republic of Serbia, currently owned by company Progetti d.o.o. Vladimirovci, with registered seat at 52 Ive Andrića St., Vladimirovci, Republic of Serbia, company number 08731136, by purchasing 70% of shares in company F.LLI ROSSI SHOES on the part of company G Distribution.

II **IT SHALL BE ESTABLISHED** that the notifying party, company G Distribution B.V. from the Netherlands, had made payment in the amount of XXX euros on December 20, 2019 into the account of the Commission for Protection of Competition, which represents the fee charged for issuing a merger clearance decision in summary procedure.
