Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), in proceedings instituted on receipt of the Merger notification No. 6/0-02-521/2020-1 of July 28, 2020 filed by companies Društvo sa ograničenom odgovornošću za uvoz, izvoz, proizvodnju, promet i usluge u prometu „DASTO-SEMTEL“ Bijeljina, with registered office at 98 Račanska St., Bijeljina, Bosnia and Herzegovina, and „NOVA BH“ društvo sa ograničenom odgovornošću Sarajevo, with registered office at 10 Trg solidarnosti Sq., Sarajevo, Bosnia and Herzegovina, via procuration holder, attorney at law Veljko Smiljanić from the Law Office of Karanović & Partners, 23 Resavska St., Belgrade, on August 20, 2020, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of joint control on the part of companies Društvo sa ograničenom odgovornošću za uvoz, izvoz, proizvodnju, promet i usluge u prometu „DASTO-SEMTEL“ Bijeljina, with registered office at 98 Račanska St., Bijeljina, Bosnia and Herzegovina, company number 59-01-0012-14, via affiliated company „TELEVIZIJA JEDAN“ Društvo sa ograničenom odgovornošću Sarajevo, with registered office at 25 Branilaca Sarajeva St., Sarajevo, Bosnia and Herzegovina, company number 65-01-0135-13, and „NOVA BH“ društvo sa ograničenom odgovornošću Sarajevo, with registered office at 10 Trg solidarnosti Sq., Sarajevo, Bosnia and Herzegovina, company number 65-01-0500-08, over company “Multiplex Service BH” Društvo sa ograničenom odgovornošću Sarajevo, with registered office at 20 Branilaca Sarajeva St., Sarajevo, Bosnia and Herzegovina, company number 65-01-0676-18, by way of purchase of shares.
