The President of the Commission for Protection of Competition, pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, Nos. 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, No. 49/11), in proceedings instituted on receipt of Merger notification No. 6/0-02-469/2021-1 of May 31, 2021, filed by the following companies: AFI EUROPE N.V., having its registered office address at Herengracht 456, 1017 CA Amsterdam, the Netherlands; AFI ZMAJ WEST doo Beograd, having its registered office address at 88-90 Omladinskih brigada St., Belgrade, Republic of Serbia; and, AFI ZMAJ EAST doo Beograd, having its registered office address at 88-90 Omladinskih brigada St., Belgrade, Republic of Serbia, through their procurator holder, attorney at law Oliver Glišić, 1a Trnska St., Belgrade, on July 12, 2021, enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of individual control on the part of the following companies: AFI EUROPE N.V., having its registered office address at Herengracht 456, 1017 CA Amsterdam, the Netherlands, company number 34218161; AFI ZMAJ WEST doo Beograd, having its registered office address at 88-90 Omladinskih brigada St., Belgrade, Republic of Serbia, company number 21636860; and, AFI ZMAJ EAST doo Beograd, having its registered office address at 88-90 Omladinskih brigada St., Belgrade, Republic of Serbia, company number 21636878, over a part of AIK BANKA a.d. Beograd, having its registered office address at 115đ Bulevar Mihajla Pupina Blvd., Belgrade, Republic of Serbia, company number 06876366, which may represent an independent business entity, by way of purchase of assets that includes the cadaster parcels 16355/1/2/3/4 and 16350/1/2/3/4 Cadaster Municipality (CM) Zemun or immovable properties on these cadaster parcels, specifically the building land on said parcels and buildings located on the cadaster parcels 16355/1 and 16350/1 CM Zemun.

II IT SHALL BE ESTABLISHED that the notifying parties, AFI EUROPE N.V., AFI ZMAJ WEST doo Beograd, and AFI ZMAJ EAST doo Beograd, have made payment in the amount of XXX dinars on May 31, 2021 into the account of the Commission for Protection of Competition, which the fee charged for issuing a merger clearance decision in summary procedure, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
